Re- The closure of Falmouth Multi-Academy Trust - FalmouthMAT

Falmouth Multi-Academy Trust Accounts will close on the **31st August 2020**. This is due to the Regional Schools' Commissioner's decision to re-broker Falmouth School into another multi-academy trust.

Our schools which are based in Cornwall, are Falmouth School, King Charles CE Primary School and St Francis CE Primary School and will be transferring to two other multi-academy trusts and I am writing to inform you of their destinations and contact details for these – see table below.

I am requesting that all outstanding invoices, credit notes and financial statements reach Falmouth MAT in good time and preferably by **5th August 2020** so that they can be processed and paid prior to the closure of our trust accounts. We would also be grateful if you could ensure that any outstanding cheques from Falmouth MAT are processed so that these are cleared by the end of August 2020 as the bank account will be closed. As you will be aware we now pay the invoices by BACS.

If we are paying your company by direct debit then these will be cancelled. Please ensure new mandates are sent to us via **matfinance@falmouthmat.org.uk** to complete with the new MATs bank account details and signatures.

Our three schools will be transferring to two different multi-academy trusts on the **1st September 2020**.
